MEMORANDUM OF AGREEMENT

between

University of Limerick, Limerick, Ireland

and

Worcester State University, Massachusetts, USA

BACKGROUND

- (A) Worcester State University and University of Limerick wish to enter into an agreement to facilitate the entry by students of Worcester State University to a relevant University of Limerick degree programme as listed in Appendix 1; and
- (B) This Agreement ("**this Agreement**") is intended to be legally binding upon the parties.

1. Commencement and Duration

It is intended that the terms of this Agreement will remain in force for a period of 5 years from the last date of signature of this Agreement, (the "Commencement Date") and unless otherwise terminated in accordance with the provisions of clause 6. The parties shall review and evaluate the operation of all matters under this agreement between the fourth and prior to the fifth anniversary of the Commencement Date. Any renewal or amendment of this agreement shall be made in writing and agreed by both parties.

2. Scope of Relationship

- 2.1 This Agreement covers the provision by University of Limerick of programme information and all other relevant information to Worcester State University and the promotion by Worcester State University of this arrangement to its students, with the intention that students will be able to transfer from their programme at Worcester State University into a University of Limerick degree programme.

- 4.4 University of Limerick will forward relevant information directly to students on request and provide guidance on the University of Limerick programme applied for. With the exception of the information detailed in clause 4.3 of this Agreement, Worcester State University will not be responsible to the student for the provision of information.
- 4.5 Students who meet the admissions criteria of University of Limerick will be informed of this decision directly and any offers either unconditional or conditional will be made directly to the student. Worcester State University will not be responsible for communications between the student and University of Limerick.
- 4.6 Once enrolled with University of Limerick, the student will be subject to University of Limerick Academic Regulations and standard policies and procedures.

5 Admission process

- 5.1 Students who have completed a programme or part of a programme at Worcester State University in Column 1 of Appendix 1 with levels of achievement specified in Column 3 of Appendix 1 will be deemed to have met the academic requirements for admission to the University of Limerick programme specified in Column 2 of Appendix 1.
- 5.2 Students who have **not** completed the programme or part programme at Worcester State University with levels of achievement specified in Column 1 of Appendix 1 or who wish to study a programme **not** listed in Column 2 of Appendix 1 may apply individually for admission to University of Limerick in the normal manner.
- 5.3 Students must also satisfy the English language requirements specified in Column 4 of Appendix 1. Students who do not meet this requirement may be given a conditional offer.
- 5.4 The parties may amend the lists of programmes and admission criteria stated in Appendix 1 by written agreement signed by both parties at any time.
- 5.5 University of Limerick and Worcester State University will agree student numbers annually in advance. University of Limerick does not guarantee that all students at Worcester State University who wish to undertake a programme detailed in Appendix 1, and who meet the relevant criteria for admission, will successfully secure a place at University of Limerick.
- 5.6 All applicants to University of Limerick are required to comply with the University of Limerick's normal admissions processes outlined <https://www.ul.ie/international/applying-ul> . This includes complying with the Irish Visas and Immigration procedures on international student immigration. Support will be given to applicants by University of Limerick staff.

6 Termination

- 6.1 During its application, this agreement may be terminated at any time by one or the other party, by registered letter with acknowledgment of receipt, observing a 6 (six) months' notice period, and subject to the completion of ongoing training and mobility programmes.
- 6.2 The Agreement will automatically terminate if either party becomes insolvent or is subject to a change of control.

7 Branding

- 7.1 Worcester State University undertakes not to use any University of Limerick logo or trade mark in relation to this Agreement without the prior written consent of University of Limerick. Any material in any media produced by Worcester State University that uses any University of Limerick logo or trade mark is to be subject to the review and written approval of University of Limerick. The same shall also apply regarding the use of Worcester State University's logo by University of Limerick.
- 7.2 University of Limerick and Worcester State University may develop joint marketing campaigns using co-branding during the period of this Agreement. Such campaigns will be subject to mutual agreement, and separate terms and conditions will be formulated at that time.

8. Data Protection

- 8.1 Both parties agree to comply with the requirements of the European General Data Protection Regulation and to reasonably assist each other with ensuring compliance.
- 8.2 Worcester State University agrees to comply with all reasonable instructions of UL with regard to processing of any personal data on behalf of UL.

9. General

- 9.1 Unless this Agreement expressly states otherwise, no right or obligation arising under this Agreement may be assigned, transferred or otherwise disposed of, in whole or in part, without the prior written content of the parties.
- 9.2 Unless this Agreement expressly states otherwise a person who is not a party to this Agreement has no right to enforce any of its terms.
- 9.3 Each party will cover its own costs in relation to the activities under this Agreement.

10. Financial Arrangements

- 10.1 The University of Limerick may provide students who have transferred from the Worcester State University with a merit-based scholarship depending on their academic results in line with the International Scholarships Policy: <https://www.ul.ie/gps/international-student/scholarships-international-students/international-scholarships-policy>
- 10.2 The tuition fees due each year will be published on the relevant programme page of the University of Limerick website.
- 10.3 Students will be responsible for all accommodation and living costs.
- 10.4 University of Limerick requires all non-EU students who are not sponsored to submit annual tuition fees in full in advance of the academic year. Full details will be provided to all applicants during the application process.

11 Governing Law


- 11.1 This Agreement is (and all discussions and any legal Agreements prepared in connection with this Agreement) governed by and construed in accordance with the law of Ireland.
- 11.2 The parties irrevocably agree that the courts of Ireland have exclusive jurisdiction to settle any dispute or claim which arises out of or in connection with this agreement.




